Grand Union House - Head Lease Arrangements

Many thanks for your letter of 19th March with its enclosures and I am also very sorry to learn that Sainsburys appear to have pulled out of the deal. I note there is a possibility that they will reconsider but, like you, I am rather doubtful about this.

I was also sorry to see the tone of the BFI's letter to Ms Wonfor and I agree entirely that this needs smoothing up. However, it seems to me that it would not be impertinent to point out that one of the reasons why LFVDA want to set up a separate company to take on the Head Lease is exactly the same as the reason why BFI do not wish to take on the Head Lease themselves, i.e. the potential financial liabilities.

I am also sorry to learn that you were not asked to continue as permanent Chief Executive of the Agency but I hope that there are some positive developments during the next two months while you are still in charge and I look forward to hearing from you again.
